Sponsor assumes responsibility for security of the Common Area including assuring that access through all exterior doors are monitored and/or controlled during the event. Sponsor/Co-Sponsor assumes all responsibilities for the condition of the Common Area used for the event, including walls, floors, windows, doors, and other areas. In the event that there is damage caused to the Common Area during the event, the cost of repairs will be deducted from the Deposit. If the amount of the deposit is not sufficient to cover the cost of repairs, the Sponsor/Co-Sponsor will be financially responsible for any additional costs. In the event that the deposit is not sufficient to cover repair costs, an additional deposit in the amount of the estimate of unpaid costs must be paid in full within 10 days of the event. Any refund of unused deposit or additional deposit will be made to Sponsor/Co-Sponsor within 10 days of event or completion of required repairs. The attached Inspection Report will be used to determine any damages incurred during the event. No alcoholic beverages may be served to anyone under the legal drinking age. All alcoholic beverages must be served within a Unit. Sponsor/Co-Sponsor is responsible for supervision of alcoholic beverages and condition of guests relating to alcoholic consumption. Sponsor/Co-Sponsor is responsible for all actions of event guests.

Cleaning & Damage Deposit: Deposit in the amount of \$100 is required for ANY event or exhibit.

Notice: Once approved, notice to the residents of the event must be posted at least 10 days in advance. If the Event or Exhibit is a "last-minute" item, the Board of Directors must approve a late posting.
